#### LEGAL FRAMEWORK

#### Mr. Speaker, Sir,

The Committee confined its activities within the following statutes inter alia;

- (i) Chapter 6 of the Constitution of Kenya (2010) Leadership and Integrity
- (ii) Section 8(1) (a) of the County Governments Act, 2012
  - 8. (1) the county assembly shall -
  - (a) Vet and approve nominees for appointment to county public offices as may be provided for in this Act or any other law;
- (ii) Section 14 (3) of the County Governments Act, 2012

In considering any appointment for which approval of the county assembly is required under the Constitution, an Act of Parliament or county legislation—

- (a) the appointment shall be considered first by a committee of the county assembly;
- (b) the committee's recommendation shall be tabled before the county assembly for approval; and
- (c) the proceedings of the committee and the county assembly shall be open to the public.
- (iv) Order No.172 of Nyamira County Assembly Standing Orders.

Powers and privileges of committees

- 172. Committees shall enjoy and exercise all the powers and privileges bestowed on County Assembly by the Constitution and statute, including the power to summon witnesses, receive evidence and to request for and receive papers and documents from the Government and the public.
- (v) The Committee strictly adhered to the procedures provided for in the Public Appointments (County Assemblies Approval) Act, 2017
- (vi) The Urban Areas and Cities Act, 2011

# 13. Boards of cities

- (1) A board of a city shall consist of not more than eleven members, six of whom shall be appointed through a competitive process by the county executive committee, with the approval of the county assembly.
- (2) Of the members referred to in subsection (1), at least five shall be nominated by –
- (a) an umbrella body representing professional associations in the area;
- (b) an association representing the private sector in the area;
- (c) a cluster representing registered associations of the informal sector in the area;
- (d) a cluster representing registered neighbourhood associations in the area; and

- (e) an association of urban areas and cities, and appointed by the county executive committee with the approval of the county assembly.
- (3) The executive committee shall, while appointing members of the board, ensure gender equity, representation of persons with disability, youth and marginalised groups.
- (4) A person shall not be appointed a member of the board unless that person—
- (a) is a citizen of Kenya;
- (b) is ordinarily resident or has a permanent dwelling in the city;
- (c) carries on business in the city; or
- (d) has lived in the city for at least five years.

#### 14. Boards of Municipalities

The provisions of section 13 shall apply with respect to the board of a municipality except that such board shall comprise nine members of whom four shall be appointed and five elected in the prescribed manner.

# 2.1 Notification of nominees to the Nyamira Municipality Board

Pursuant to Article 179 (2) of the Constitution of Kenya 2010 and Section 6(1) of the Public Appointments (County Assemblies Approval) Act 2017, the Executive Committee Member for Lands, Housing and Urban Development forwarded to the Clerk of the County Assembly of Nyamira, names of 9 nominees vide a letter dated 29<sup>th</sup> October 2018 for approval by the County Assembly and subsequent appointment as Members of the Nyamira Municipality Board as per the table below.

The names of the nominees and their testimonials were thereafter forwarded to the Committee on Appointments to conduct approval hearings.

#### 2.2 Notification to the Nominees and Members of the Public

#### Mr. Speaker Sir,

On 30<sup>h</sup> November, 2018, the Clerk of County Assembly of Nyamira, Pursuant to Section 6(2) and 7(4) of the Public Appointments (County Assemblies Approval) Act of 2017, notified the nominees and members of the public of the time and place for holding of the approval hearings. The Clerk further notified the public of Section (7) 10 of the said Act which provides that "any person may, prior to the approval hearing, and by written statement on oath, provide the Clerk with evidence contesting the suitability of a candidate to hold the office to which the candidate has been nominated" (Annexure 1).

The Committee complied with the Constitutional requirements, legal provisions and established procedures throughout the vetting process.

However, the Committee received a letter from the County Secretary Ref. No.NCG/CS/CAN/35/VOL.III/011 dated 4<sup>th</sup> December, 2018 on timelines for appointment of

the Board Members and a deadline for qualification for receipt of a grant towards the Municipality which necessitated the change of dates from  $10^{th}$  &  $11^{th}$  December 2018 as earlier advertised to  $6^{th}$  December 2018 before members proceed for recess.

Mr. Speaker Sir, It is against this background that the Committee produced this Report.

#### 2.0 THE VETTING PROCESS

# 2.1 Vetting Guidelines

**Mr. Speaker Sir,** The Select Committee on Appointments examined the nominees following the guidelines below:

- i) Academic qualifications
- ii) Employment record and work experience
- iii) Professional association
- iv) Public office, political activities and affiliations
- v) Potential conflict of interest
- vi) Knowledge of relevant Subject
- vii) Suitability to the position
- viii) Tax compliance
- ix) Integrity

## 2.2 Committee Preliminary Observations

#### Mr. Speaker, Sir,

Before commencement of the vetting process, the Committee made the following preliminary observations and findings

# 2.2.1 Statutory Requirements for Nominees

- (i) The nominees have the requisite qualifications and experience.
- (ii) That the nominees met the requirements of Chapter Six of the Constitution of Kenya: tax compliance Certificate, Police Clearance Certificate, Higher Education Loans Board Compliance, clearance by the Ethics and Anti-Corruption Commission (EACC) and Credit Reference Bureau.
- (iii) The committee further noted that the principle of two-third gender rule was considered in appointing the nominees.

#### VETTING OF THE NOMINEES TO THE NYAMIRA MUNICIPALITY BOARD

#### Mr. Speaker, Sir,

The Committee received a total of nine nominees for vetting and subsequent appointment to the Nyamira Municipality Board. The Committee scheduled to conduct vetting for two nominees to a later date.

The seven nominees were vetted as hereunder;

#### 3.0 Fr. CHRISANTUS MAINYE

#### 3.1 Nominee Personal Details

Mr. Speaker, Sir,

The Nominee is a male, 60 years old and hails from Manga Ward.

#### 3.2 Academic, Professional Qualifications and Working Experience

Mr. Speaker, Sir,

**Fr. Chrisantus Mainye** is a holder of a Diploma in Theology and a Certificate in Religious Studies and Philosophy. He has worked as Priest for 31 years.

#### 3.3 Committee Findings on Fr. Chrisantus Mainye

#### Mr. Speaker, Sir,

The committee found the Nominee to be generally qualified for the position. He is knowledgeable, coherent, eloquent and articulate in addressing issues related to this docket.

He scored an average of 71% from the assessment made by the Select Committee on Appointment using Schedule 2 criteria set out in the Public Appointments (County Assemblies Approval) Act, 2017.

The Committee therefore recommends to the County Assembly that the nominee Fr. Chrisantus Mainye be appointed to the position of Member, Nyamira Municipality Board.

#### 4.0 MR. SIMEON MOCHECHE BOGONKO

#### 4.1 Personal Details

Mr. Speaker, Sir,

The Nominee is a male adult of 54 years old, married and hails from Bonyamatuta ward.

#### 4.2 Academic, Professional Qualifications and Working Experience

The Committee therefore recommends to the County Assembly that the nominee Mr. Simeon Mocheche Bogonko be appointed to the position of Member, Nyamira Municipality Board.
