I now have the following communications to make:

1. <u>DECLARATION OF INCOME, ASSETS AND LIABILITIES BY STATE</u> AND PUBLIC OFFICERS

Pursuant to Section 26(1) of the Public Officer Ethics Act, 2003 all state or public officers are required to, once every two years, submit a declaration of income, assets and liabilities of him/herself, spouse(s) and dependent children under the age of 18 years.

It is further expected that all persons elected or appointed to state or public offices make their initial declarations failure to which is a criminal offence under Section 32 of the Act which renders to a non-compliant officer, upon conviction, liable to, a fine not exceeding one million shillings or imprisonment for a term not exceeding one year or both; and could constitute a breach of Chapter six of the Constitution.

The deadline for declaration is 31st December, 2017 and Members are therefore advised to contact the Human Resource office to be guided on the process.

2. WARD STAFF

This is to notify those elected Members who have not submitted the names of respective Ward Staff to do so immediately. This is so because the said members of staff are supposed to be captured in the payroll for November salaries.

3. BOGICHORA WARD ELECTION

The election for Member of County Assembly (MCA) Bogichora Ward was conducted on the 7th of November, 2017. The exercise having been concluded successfully, the Assembly will swear in the MCA-Elect once the name is published in the Kenya Gazette.
