COMMUNICATION FROM THE CHAIR

"Honorable Members,

This House adjourned its Wednesday Sittings this week following an adjournment Motion moved on the Floor by the honorable Leader of Majority. In his motion, the honorable Member persuaded the Assembly to adjourn in order to allow Members of the NASA Coalition who form the majority to stand in solidarity with the Governor who was to be in the High Court of Nyamira for a ruling on an election petition challenging his victory in the gubernatorial elections.

In addition to that, the ruling coincided with those of three other Members of this House. Cognizant of the fact that the County Assembly Calendar is important in determining sittings of this House; honorable Members, you took exception in this case not only to stand with the Governor but also your colleagues who were facing the same fate in court.

I was pleased to learn that the election of the Governor was upheld as was that of two of the three Members of our County Assembly. However, I also learnt that the court had in its wisdom upheld a Kenya Gazette Notice that had degazetted one of the Special-Elect Members of this House. I congratulate and welcome hon. Irene Nyakerario Mayaka of ODM Party who has been duly sworn in as a Member of this House.

Honorable Members,

In regard of the matter of election petitions let me single out the following honorable Members who emerged victorious in the August 2017 elections and were resoundingly vindicated even after being dragged to courts. I now ask the Members to stand at the mention of their names to receive congratulations from the Chair and applause from the Members:

The collapse of your election petitions no doubt leaves you with the demanding duty of delivering on your election pledges just like is expected of all of us.

Honorable Members,

I now wish to draw your attention to the Public Finance Management, 2012 Section 117 which requires the County Treasury to prepare and submit the County Fiscal Strategy Paper to the County Assembly for approval by 28th February every year. The Executive Committee Member, Finance and Planning sent a letter to the County Assembly which was received on 27th February,

2018 requesting for a one week extension to 7th March, 2018 to be able to submit the CFSP. Considering the reasons quoted therein and in consideration of Section 90 of the PFM Act, the request was granted and the CEC Member is therefore expected to abide by the new timeline without further delay.

Honorable Members.

I now wish to draw your attention to Standing Order 180(6) which, in part, stipulates that a report of a select committee shall be laid on the Table of the County Assembly by the Chairperson or the vice-Chairperson or by a Member authorized by the committee on its behalf within fourteen days of the conclusion of its proceedings.

I am making reference to a Communication I made on 22nd of February asking all committees that sat over the recess period to deliberate on various matters to submit their respective reports without delay. Some of the reports were for tabling in the House whereas others were for documentation. I have since been notified of the status of those reports as follows;
