#### **COMMUNICATION FROM THE CHAIR**

ELECTION PETITION DAMARIS MOUNI VERSES WAFULA CHEBUKATI

The Deputy Speaker (Hon. Omoti): Election Petition number 4, 2017, Damaris Mouni verses Wafula Chebukati and three others. Hon. Members this communication originates from an ongoing petition in the high court of Nyamira following the de-gazettement of hon. Damaris Nyarangi Mouni as the duly nominated Member of County assembly of Nyamira. The Clerk of the County Assembly of Nyamira is named as the fourth respondent in the matter. The said hon. member contested the degazzettement in court and was successfully granted interim orders dated 12<sup>th</sup> and 25<sup>th</sup> September respectively. The matter came up for hearing on the 16th October 2017. The court issued the following orders pending interparty hearing;

- (a) That pending the hearing of the instant application a stay of legal Notice No. 133, dated  $8^{th}$  September 2017
- (b) And is here granted pending hearing and determination interparty.
- Hon. Members on the above orders this ho house is seized of the matter and without prejudice to the hon. member we are aware of the doctrine of subsidize the reason we must resist the temptation of ongoing to the roots of the petition in court. However hon. Members, this House jurisdiction to make a communication of this nature and that based on court order that:
- (a) Pending the hearing of instant application a stay of legal notice number 133, dated 8th September 2017

(b) And is hereby granted pending hearing and determination interparty. This House is seized of the the mtte and thus communicates that Damaris nyarangi Mouni be allowed to attend the house until further communication to the contrary are issued.
