AMENDMENT

The Speaker (Hon. Teya): The county Assembly procedure and rule committee established pursuant to standing order NO. 188(1) is entrusted with among others proposing amendments to the standing orders and any such amendments shall, upon approval by the County Assembly take effect at the time appointed by the Assembly.

The same committee in Standing Order 236 is required at least once in every time of the county assembly to review the standing orders and make report to the County Assembly to recommending the Standing Orders if any to be amended.

Finally, the Standing Order 235(1) permits that any member with a support of at least two other members to request a procedure and County Assembly rules and committee to consider an amendment to the standing orders.

Hon. Members in consideration of the above stated standing orders any members with a proposal for an amendment of the Standing Orders is therefore requested to present the proposal to the procedure and County Assembly and Rules committee for possible adoption in the standing orders.

Member for Itibo Ward (Hon. Nyanchama): On the point he has raised it is critical and I wanted to support it that it is good we get the activities of the following week and even though we are supposed to get the order paper earlier enough for us to be well prepared instead of being ambushed in this House .Otherwise that is in order and we maintain that action should be taken.
