## 2.0 INTRODUCTION

#### 2.1 Background

#### Mr. Speaker Sir,

Article 185 of the Constitution of Kenya, 2010 provides that the legislative authority of the County is vested in, and exercised by its county assembly.

A county assembly may make any laws that are necessary for, or incidental to, the effective performance of the functions and exercise of the powers of the county government under the Fourth Schedule.

A county assembly, while respecting the principle of the separation of powers, may exercise oversight over the county executive committee and any other county executive organs.

## Mr. Speaker Sir,

Section 14 of the County Governments Act, 2012 provides that a county assembly may establish committees consistent with its Standing Orders in such a manner and for special purposes and for general or special purposes as it may consider fit, and regulate the procedure of any committee so established.

#### Mr. Speaker Sir,

We underscore the importance of assembly committees in the exercise of the noble duty bestowed upon this House. These committees help to organize the most important work of this assembly considering, shaping and passage of bills and other legislative documents, oversighting county departments and agencies, programs and activities within their jurisdictions; and determination of matters that come to the deliberation of this House.

#### Mr. Speaker Sir,

The Committee on Selection is committed to diligence, balance and fairness in the composition of Committees of the Assembly. The Committee is bound by principles of equity, gender balance, diversity of abilities and strengths, and protection of interests of minorities as set out in Article 197 of the Constitution of Kenya, 2010 and Standing Orders 154(2) of the Nyamira County Assembly Standing Orders.

# 2.2 CONSIDERATION OF VIEWS AND FEEDBACK FROM HONOURABLE MEMBERS

#### Mr. Speaker Sir,

The Committee received views and feedback from honourable Members regarding the composition of County Assembly Committees. The views and feedback received are:

- a) Some Members had shown relative disinterest in some committees. It was reported that some Members could not be productive in certain committees because they lacked capacity and/or interest. It had been suggested that nomination to Committees should be based on interest.
- b) Some committees had become inactive because either the Chairs or their Members or both are not as vibrant as would be expected
- e) Non-attendance of committee meetings was affecting the quality of deliberations. Poor attendance has been reported in many committees.
- d) Members had petitioned realignment of committees to reflect balance and equity, and harmonize grievances from honourable Members.
- e) Hon. Hezinah Mokua had petitioned the Committee on Selection to reconsider her membership to committees as she was uncomfortable in the current composition.
- f) There was need to appraise committees and institute a monitoring and evaluation system for committees with a view of improving their performance.
- g) Hon. Irene Mayaka should be procedurally nominated to County Assembly Committees

## 2.3 COMMITTEE RECOMMENDATIONS

The Committee having analyzed all the views and feedback, made the following recommendations:

- a) The Committee on Selection to hold a meeting with Committee Chairpersons to discuss strategies to strengthen committees. The meeting will be a forum for Chairpersons to discuss the challenges they are facing and find solutions. The Chairpersons will have an opportunity to launch complaints and get guidance on way forward. Thereafter, the committee will organize a meeting of the Whole House with a view of brainstorming on these issues, reinforce discipline and attendance to committee meetings, and remind Members on their role in running of the Committees. Deliberations of the meeting will guide decisions of the Committee on Selection on realignment of Committees. Parties are requested to give advice regarding this matter.
- b) The Committee recommends a continuous appraisal, monitoring and evaluation of Committee performance and especially that of Chairpersons. The objective of this appraisal is to ensure that Members and Chairpersons remain vibrant and committed to the course.
- c) Deliberate efforts should be made to ensure that members are comfortable. The Committee on Selection will ensure balance, equity and fairness is reflected in the composition of Committees.

#### 3.0 CONCLUSION

#### Mr. Speaker Sir,

The Committee on Selection is committed to equity, balance and fairness in the composition of assembly committees. We strive to ensure renewed synergy and vibrancy in committees by addressing gaps, if any, in the membership of committees. The Committee will utilize all mechanisms at its disposal to ensure that Members are comfortable and active. While we acknowledge that it may not be possible to satisfy every Member's interest, we will strive to see that grievances are minimized. The Committee supports the course for unity of this House and will address challenges arising from composition of committees that may jeopardize House unity.
